

DO I QUALIFY TO PURCHASE A SOUND SUPPRESSOR?

TO QUALIFY TO OWN A SILENCER YOU MUST:

- * LIVE IN A STATE THAT ALLOWS PRIVATE OWNERSHIP OF SILENCERS.
- * BE AT LEAST 21 YEARS OF AGE.
- * NOT HAVE BEEN CONVICTED OF A FELONY OR PLEADED GUILTY TO DOMESTIC VIOLENCE CHARGE(S).
- * BE A UNITED STATES CITIZEN.

HOW DO I PURCHASE A SOUND SUPPRESSOR?

* FIND A "CLASS 3" DEALER IN YOUR STATE OF RESIDENCE AND PLACE AN ORDER.
THE DEALER CAN NOT BEGIN THE TRANSFER PAPERWORK TO YOUR POSSESSION UNTIL THE SUPPRESSOR IS IN HIS POSSESSION.

- * **COMPLETE BATFE FORM 4 (5320.4) IN DUPLICATE.**
 - REQUIRES LAW ENFORCEMENT SIGNATURE AND A PASSPORT SIZE PHOTO
 - MOST CLASS THREE DEALERS WALK YOU THROUGH THIS PROCESS

- * **COMPLETE BATFE FORM 5330.20 (CONFIRMING U.S. CITIZENSHIP) IN DUPLICATE.**
 - MOST CLASS THREE DEALERS WALK YOU THROUGH THIS PROCESS

- * **COMPLETE FBI FORM FD-258 (FINGERPRINT CARD) IN DUPLICATE.**
 - MOST CLASS THREE DEALERS WALK YOU THROUGH THIS PROCESS

- * **PAY THE \$200.00 TRANSFER TAX TO BATFE AFTER APPROVAL**
 - MOST CLASS THREE DEALERS WALK YOU THROUGH THIS PROCESS

**ONCE THE PAPERWORK IS CLEARED BY BATFE YOU CAN FILL OUT A
STANDARD BATFE FORM 4473 TO PURCHASE YOUR SILENCER!**
